



Terms of Use for OpOp Platform

By using the OpOp Miner WebApp (bot) to mine OpOp tokens or any related services provided by OpOp, you agree to comply with and be bound by these Terms of Use. If you do not agree with any part of this Agreement, you must immediately discontinue use of the Platform.

These Terms of Use ("Agreement") constitute a legally binding contract between you ("User") and OpOp (the "Platform", "we", "our", or "us").

#### 1. General Provisions

# 1.1 Acceptance of Terms

By using the OpOp Services (the "Services"), including but not limited to accessing the OpOp platform, mining tokens via the Telegram bot, or utilizing any associated services, you agree to abide by these Terms of Use and any applicable policies or guidelines referenced herein.

#### 1.2 Modifications to Terms

We reserve the right to amend, modify, or replace these Terms of Use at our sole discretion. Changes will be posted on the OpOp website, and continued use of the Services after such changes indicates your acceptance of the updated Terms.

#### 2. Platform Overview

#### 2.1 No Guarantee of Profit or Financial Return

OpOp provides a decentralized platform where users can mine OpOp tokens using the Telegram tapping bot. OpOp makes no promises, warranties, or guarantees regarding profits or returns on any tokens mined, nor does OpOp guarantee the market value or future performance of OpOp tokens.





#### 2.2 Token Distribution and Mining

Users are eligible to mine OpOp tokens through interaction with the Telegram bot, but the availability and distribution of tokens are solely at OpOp's discretion. OpOp tokens are not guaranteed to have any intrinsic or market value.

#### 2.3 No Financial or Investment Advice

Nothing on the Platform or provided by OpOp constitutes financial, investment, or legal advice. Users are encouraged to perform their own due diligence before engaging in any transactions or decisions related to the platform.

# 3. User Responsibilities

# 3.1 Eligibility

By using the Services, you affirm that you are at least 18 years of age or the legal age of majority in your jurisdiction. You also represent that you are not a resident of, or located in, any country where participation in the OpOp platform would be illegal.

# 3.2 Account Security

You are responsible for maintaining the confidentiality of your account and credentials. You agree to notify OpOp immediately of any unauthorized access to your account. OpOp is not liable for any loss or damage resulting from your failure to maintain the security of your account.

#### 3.3 Prohibited Use of Platform

You agree not to use the OpOp platform for any unlawful, unauthorized, or malicious activities, including but not limited to the misuse of platform data, bot manipulation, or circumventing any security measures. Using the platform, its data, or its intellectual property without prior written permission from OpOp is strictly prohibited and will be considered illegal.





## 4. Cheating and Misuse

#### 4.1 Definition of Cheating

OpOp reserves the exclusive right to define and identify what constitutes "cheating" within its ecosystem. Cheating includes, but is not limited to, actions that interfere with or manipulate the mining process, use of bots or scripts to artificially increase token mining, exploiting vulnerabilities within the platform, or any activity deemed by OpOp as fraudulent or unfair.

# 4.2 Detection of Cheating

OpOp will utilize various methods, including automated systems and manual reviews, to detect and prevent cheating. OpOp's decision regarding any user's involvement in cheating or misuse of the platform is final.

#### 4.3 Actions for Cheating

If OpOp identifies any user engaging in cheating, manipulation, or breach of these Terms of Use, OpOp reserves the right to suspend or permanently ban the user from the platform without prior notice. The banned user shall have no claim against OpOp for such actions, and they agree not to initiate any legal proceedings or disputes. Users caught cheating will forfeit any and all tokens earned, and OpOp has no liability for any financial losses incurred by the user.

# 5. Limitations of Liability

#### 5.1 No Financial Guarantee

OpOp does not guarantee any financial profit, revenue, or specific outcome through its services. Users engage in token mining or other activities at their own risk. The value of OpOp tokens may fluctuate, and you may lose access to tokens based on market forces.

OpOp only collects data provided directly by Telegram's API during your use of the OpOp mining bot. This data includes, but is not limited to, your Telegram user ID, username, and any other basic information that Telegram provides to enable the functioning of the OpOp platform. We do not collect any personal or sensitive data beyond what is provided by the Telegram API.

OpOp does not store or utilize any other information about you, your activities, or your interactions outside of the Telegram platform.

By using the OpOp platform and interacting with the Telegram bot, you consent to the collection and use of the data provided by Telegram's API as described in this section. For more details, please refer to the full OpOp Privacy Policy, which explains how your data is handled and protected.
